

Purpose of the Fit & Fun Grant:

To encourage fitness, social interaction and community involvement by providing up to \$150 to enable individuals with developmental disabilities to participate in fit and fun recreational activities and events. The grant can be used to pay for tickets, fees (admission, tuition, recreational, lessons, etc.), and travel and equipment costs (adaptive or otherwise). The grant can also be used to pay admission, fees and travel for a support person. *Examples of activities funded previously are provided on page 2 of this application.*

Eligibility:

1. At the time of application and for the duration of the grant period, receive at least one service from The Arc Otsego
2. Live on your own or with others in a non-certified setting

Submission Process:

Applications will be accepted on an ongoing basis until September 22, 2025, or when funds are exhausted. All receipts must be submitted by October 20, 2025.
